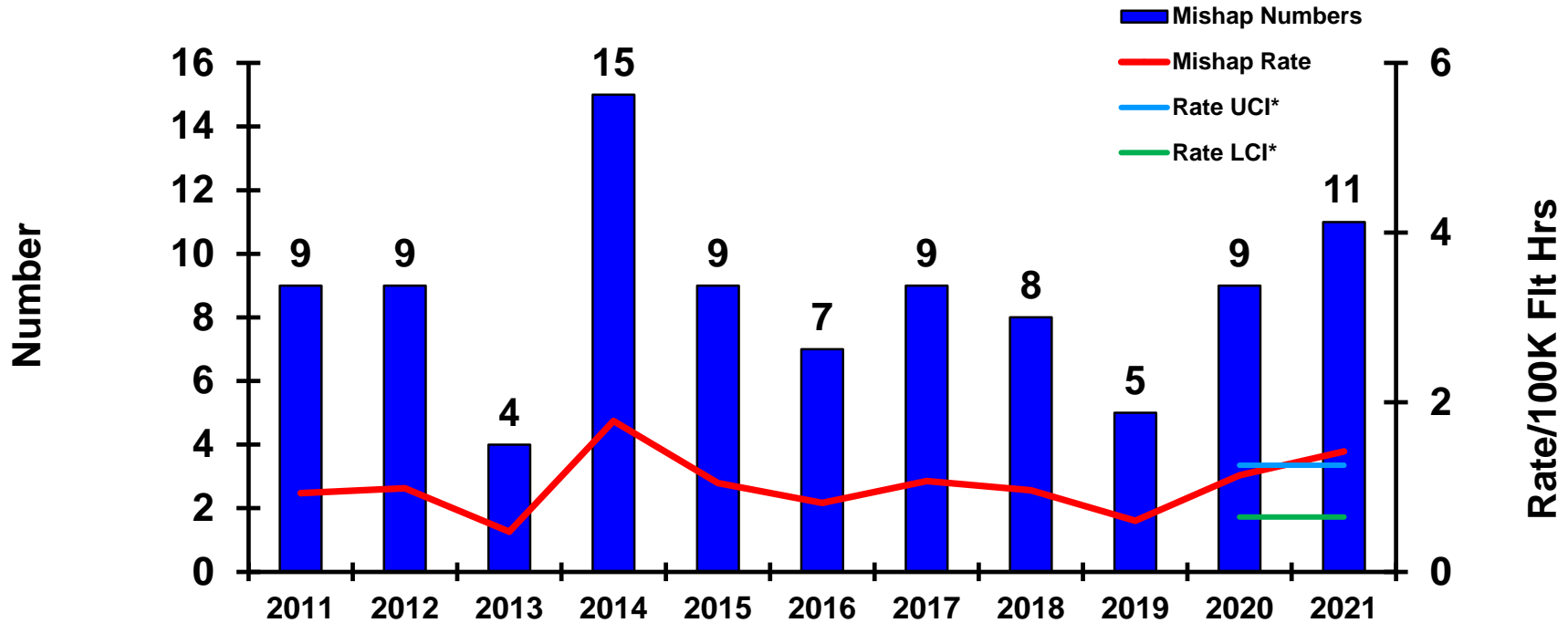

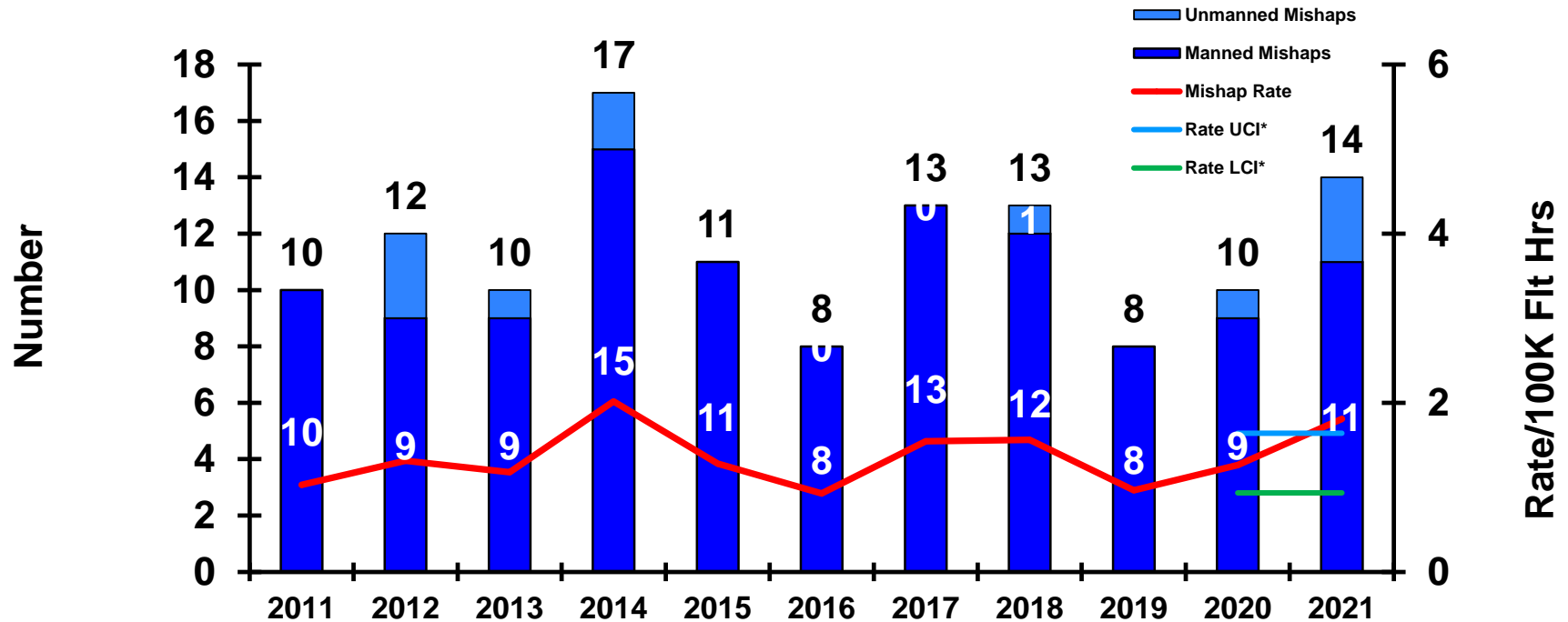

CLASS A AVIATION MISHAPS

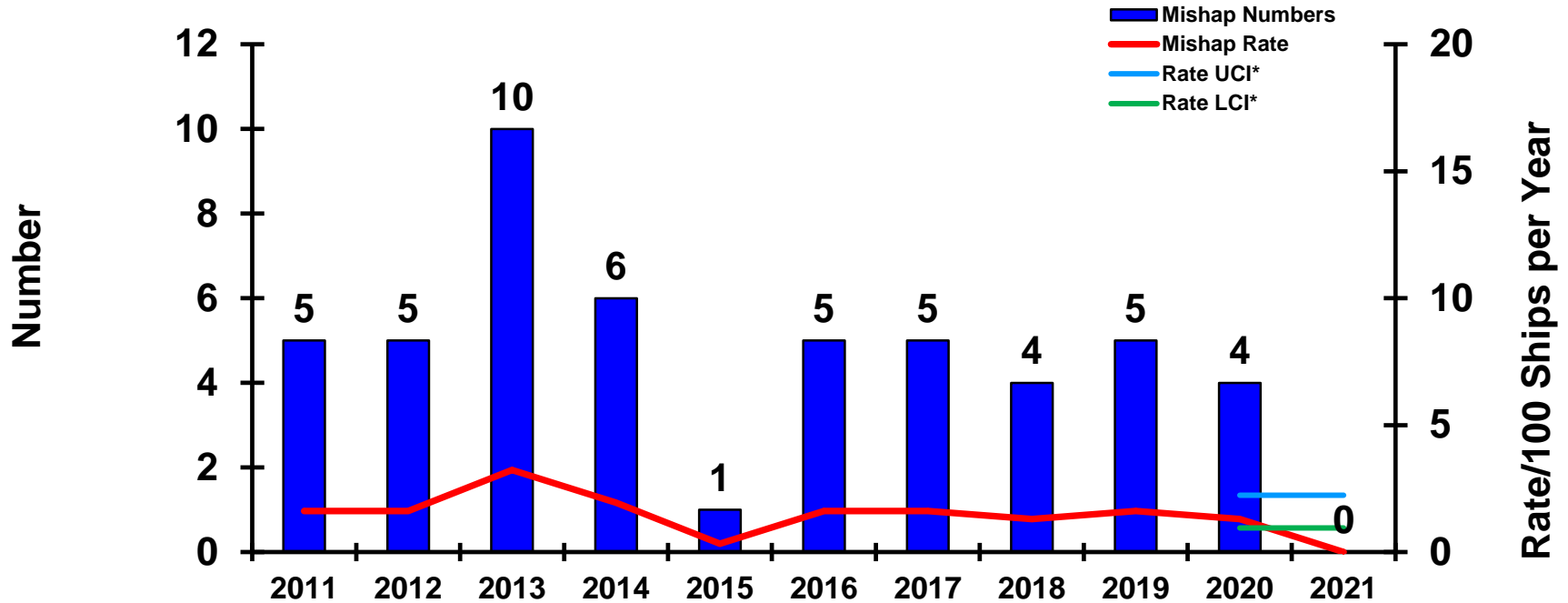

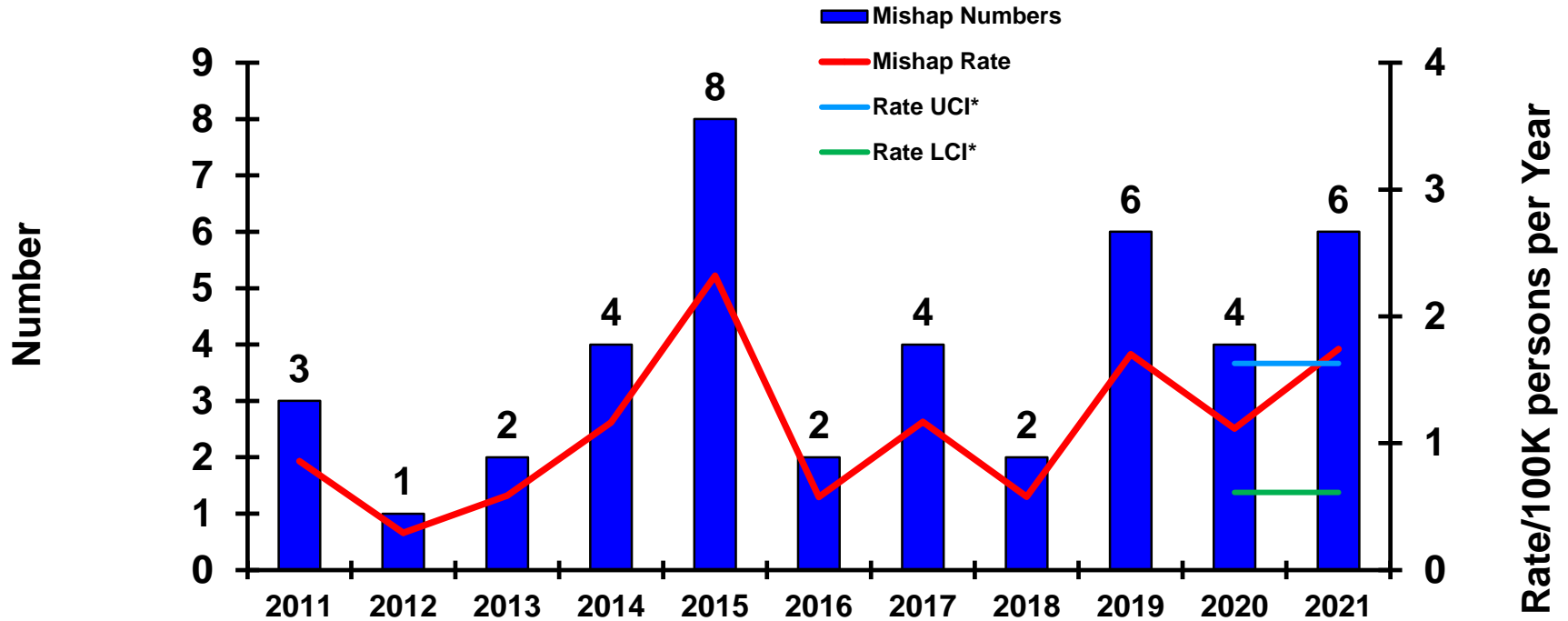

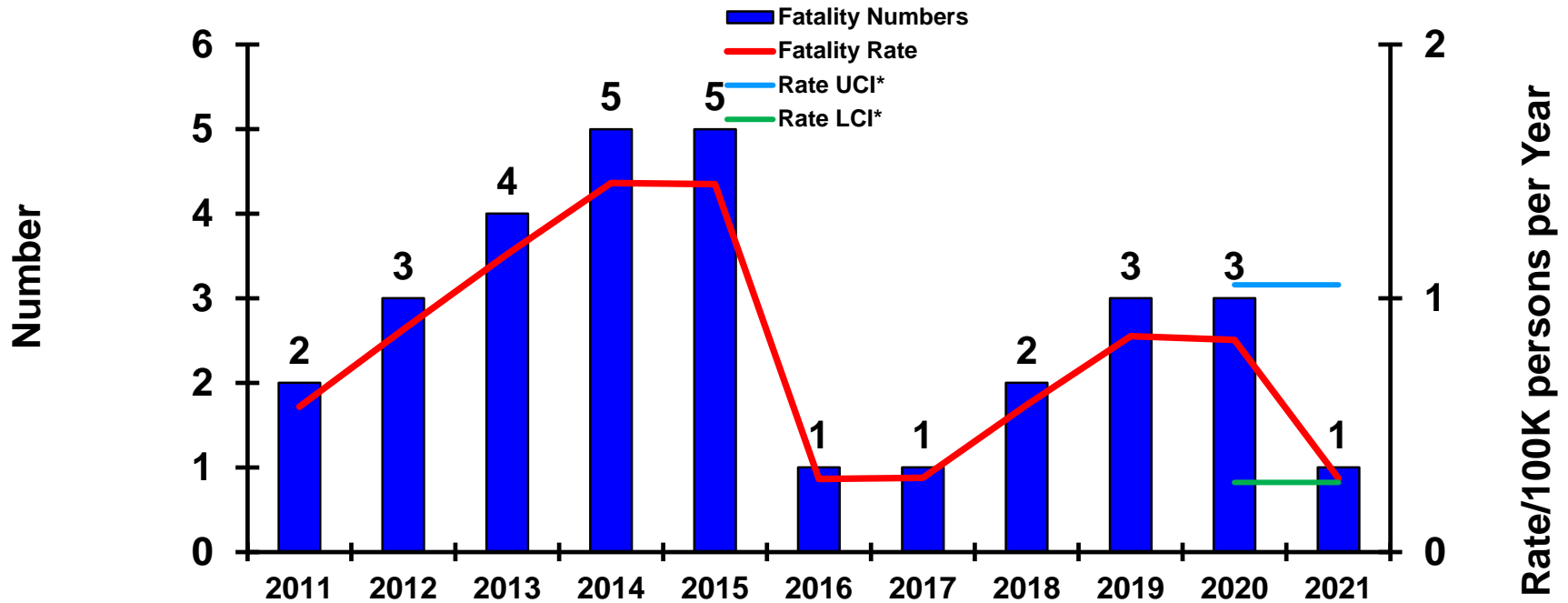

PHYSICAL TRAINING FATALITIES

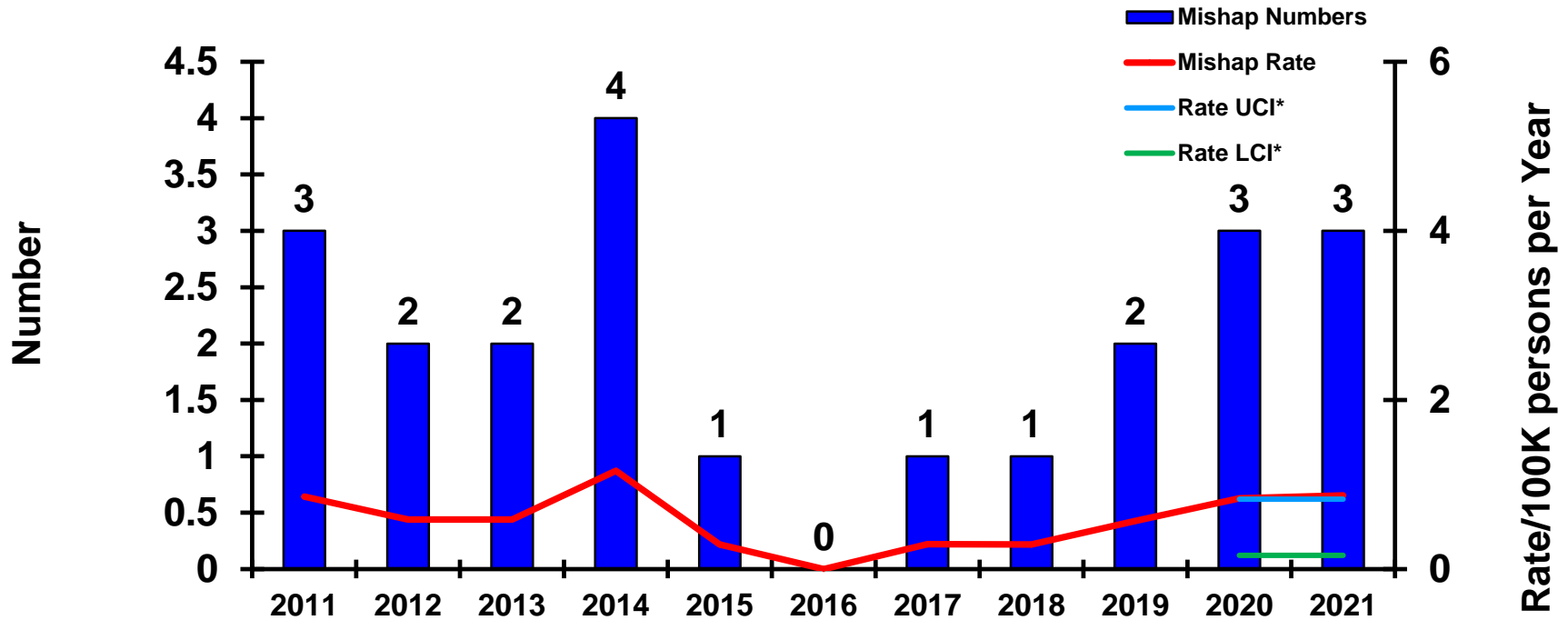

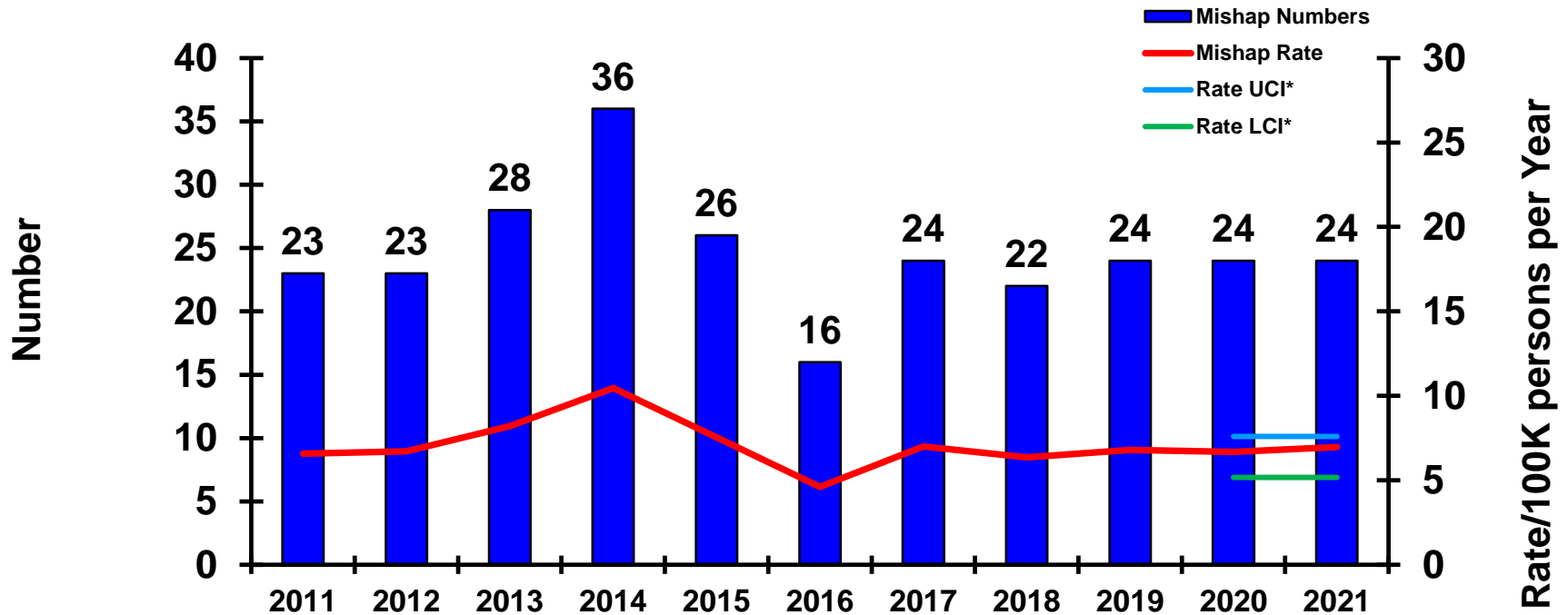

TOTAL CLASS A ON-DUTY MISHAPS

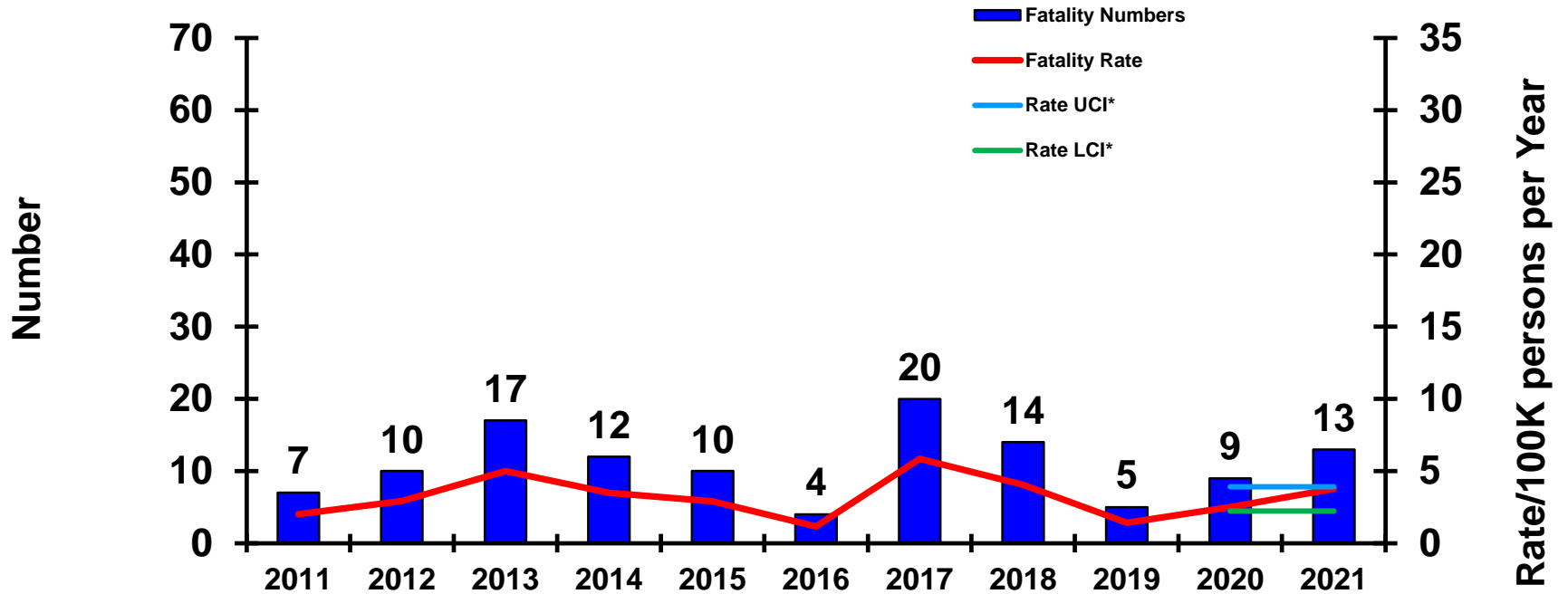

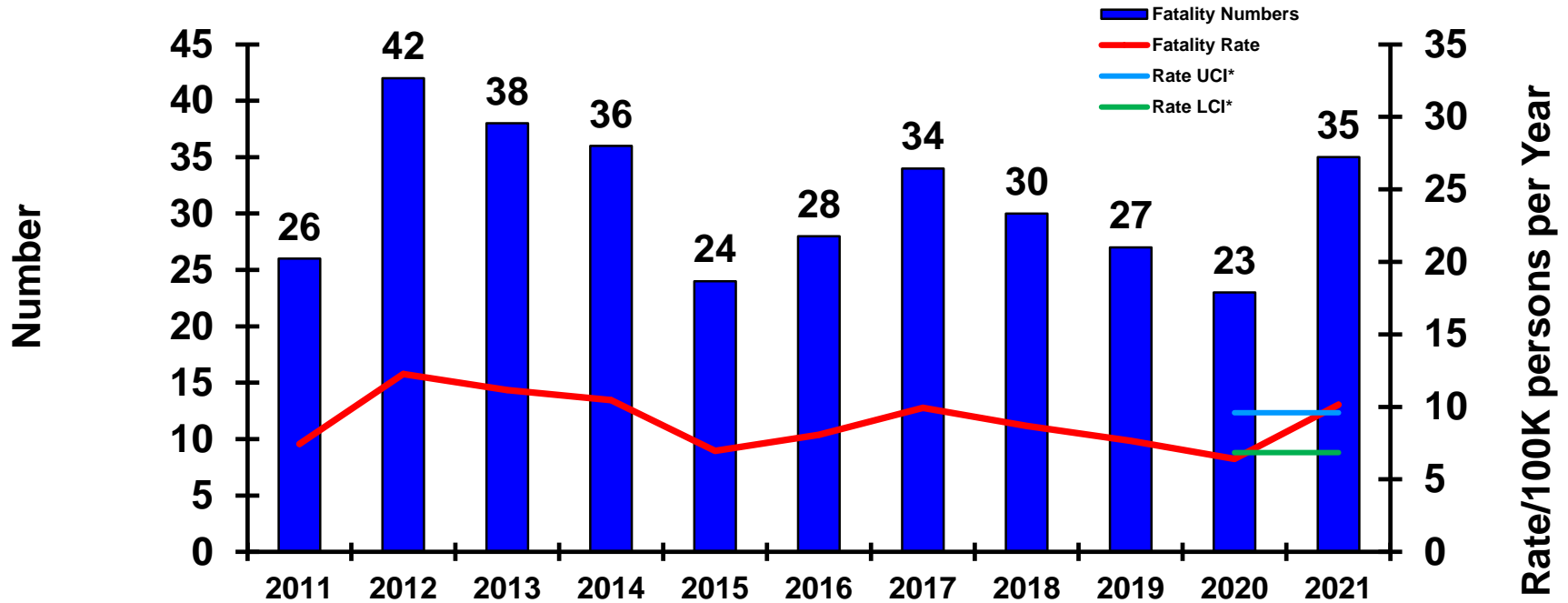

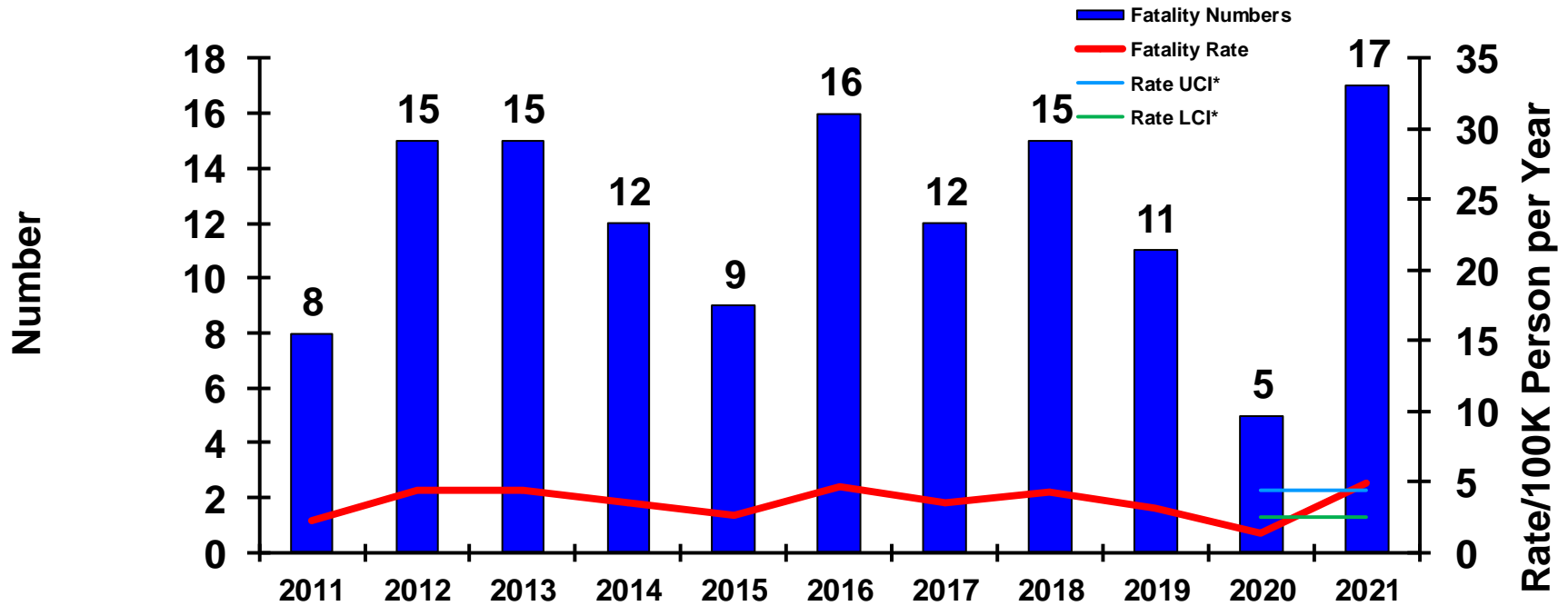

4-WHEEL PMV FATALITIES



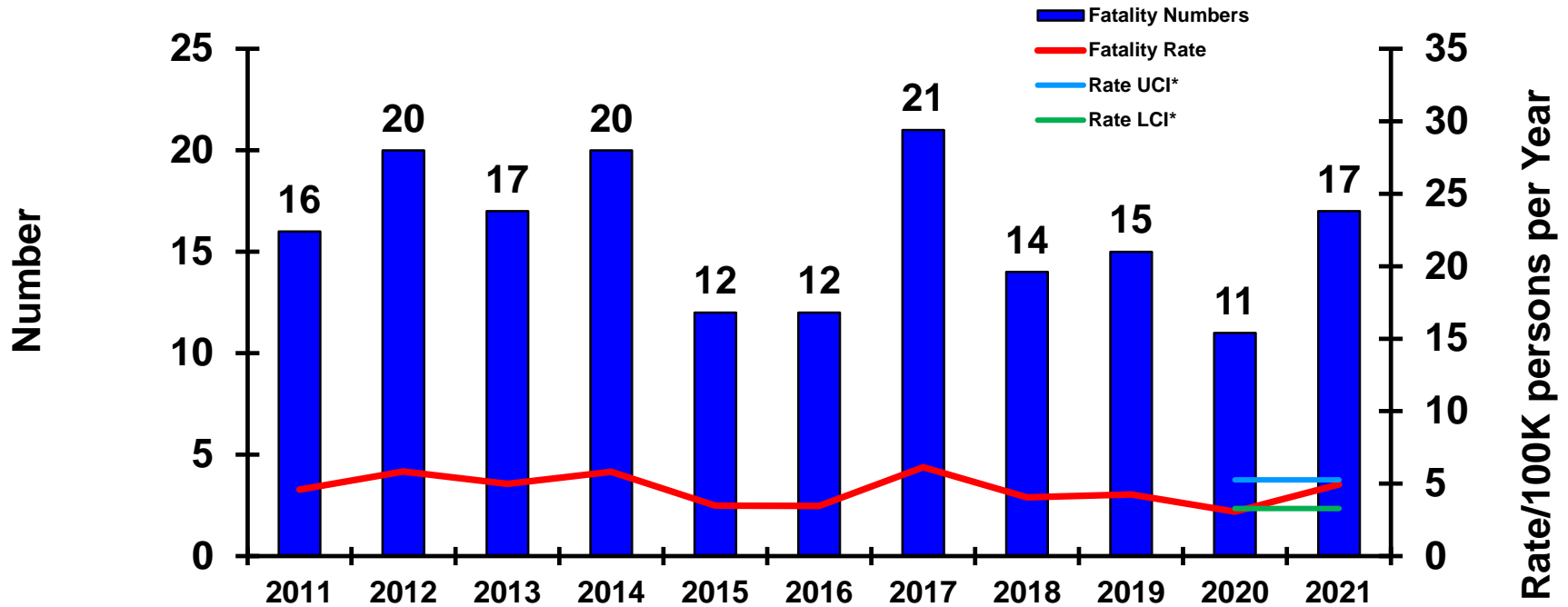

MOTORCYCLE PMV FATALITIES

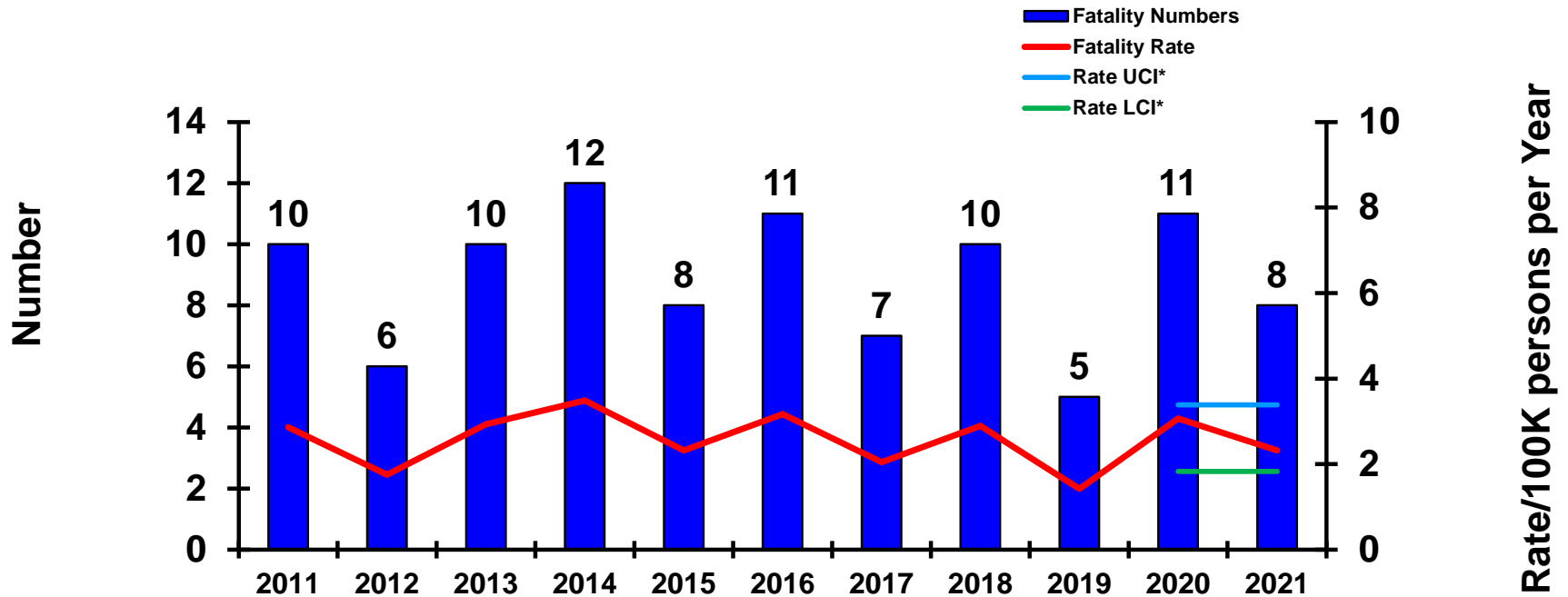

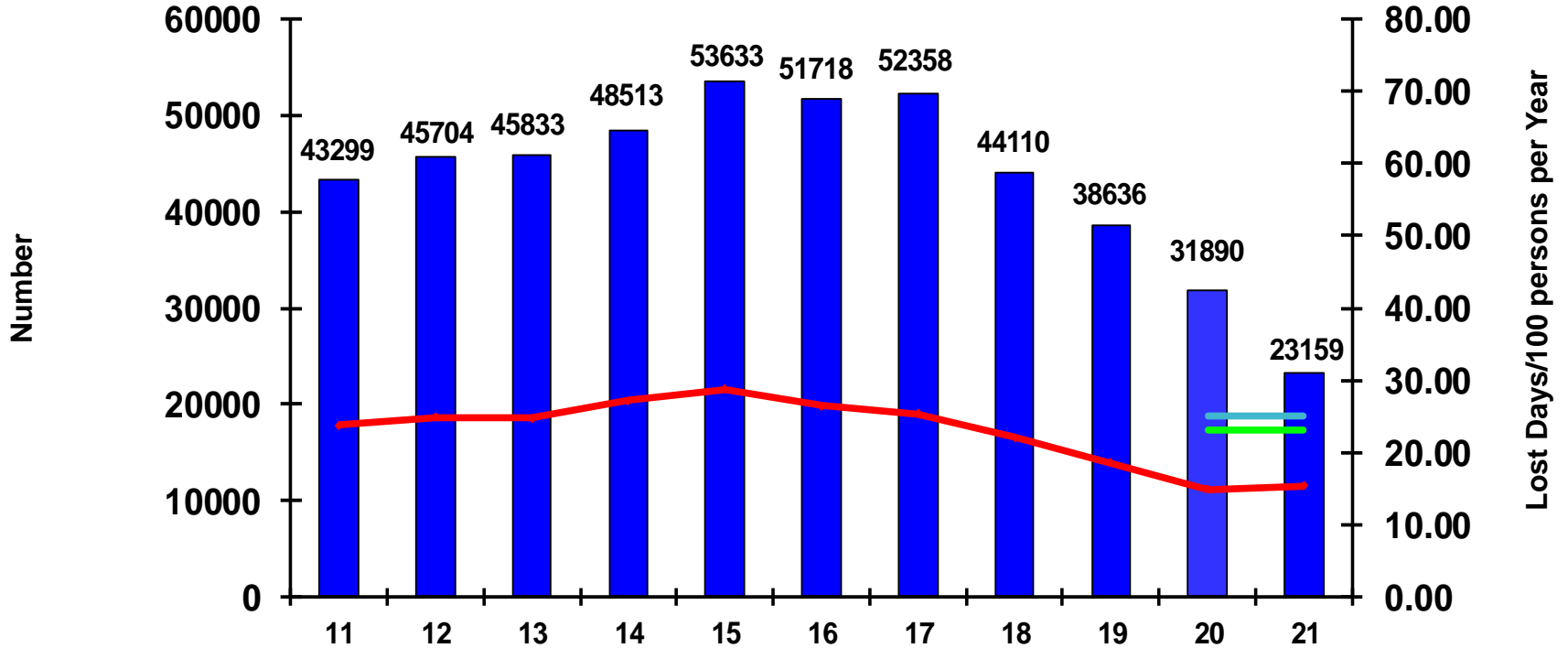

CIVILIAN LOST WORK DAY

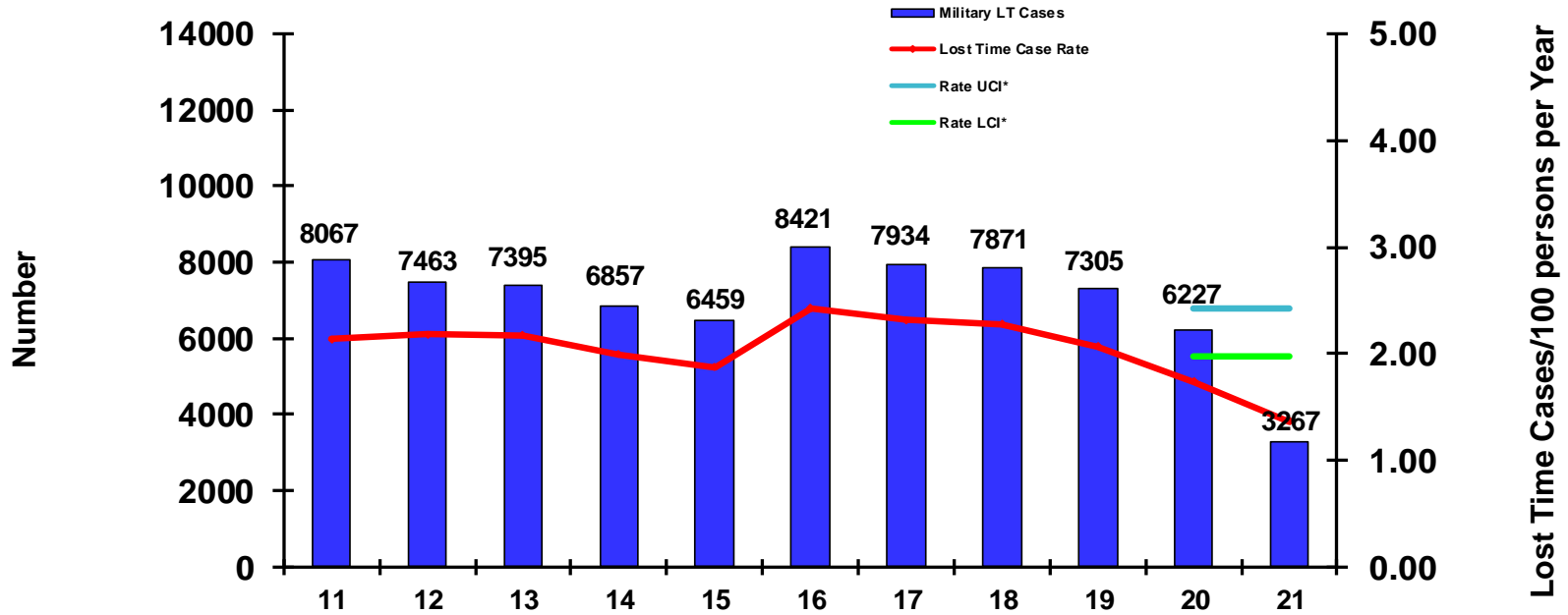

MILITARY LOST TIME CASE RATE



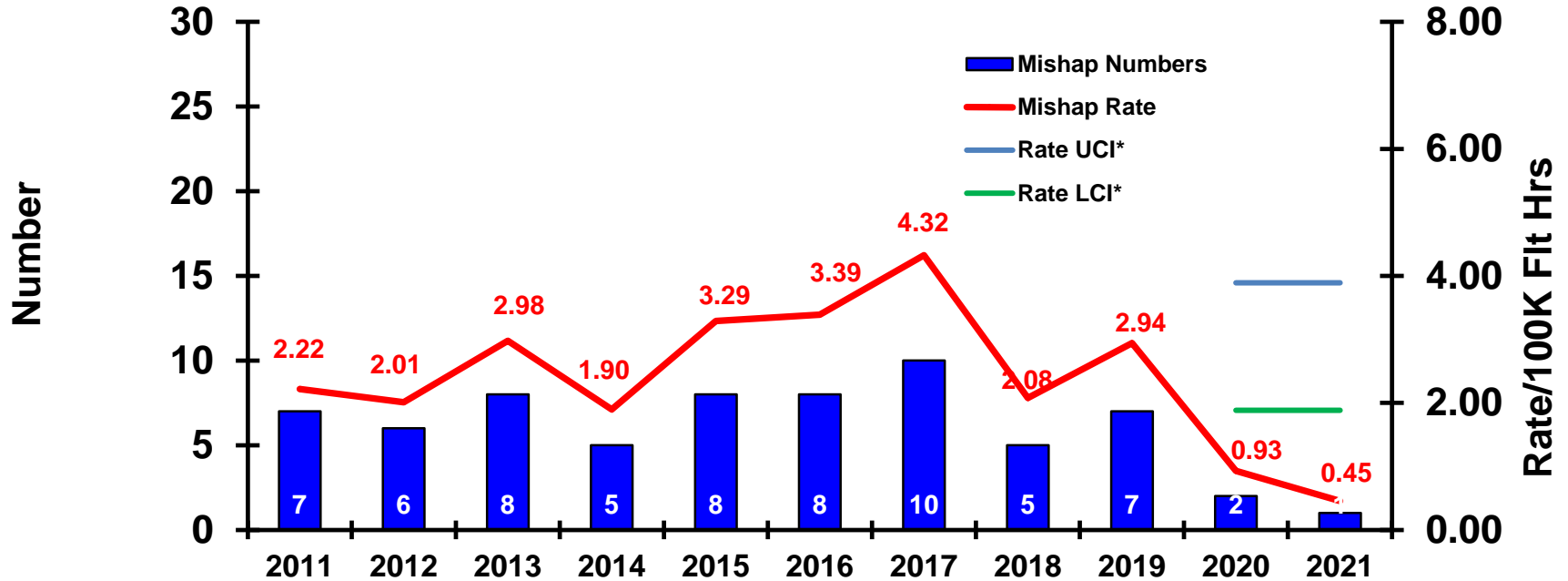

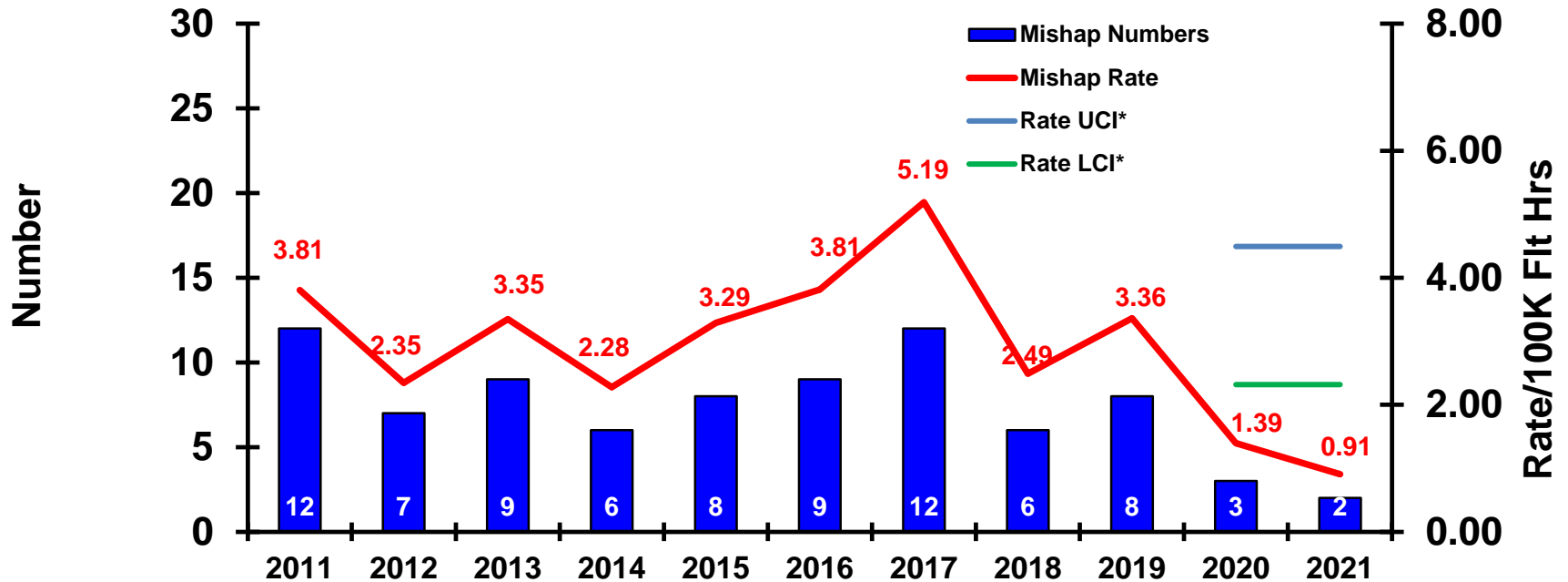

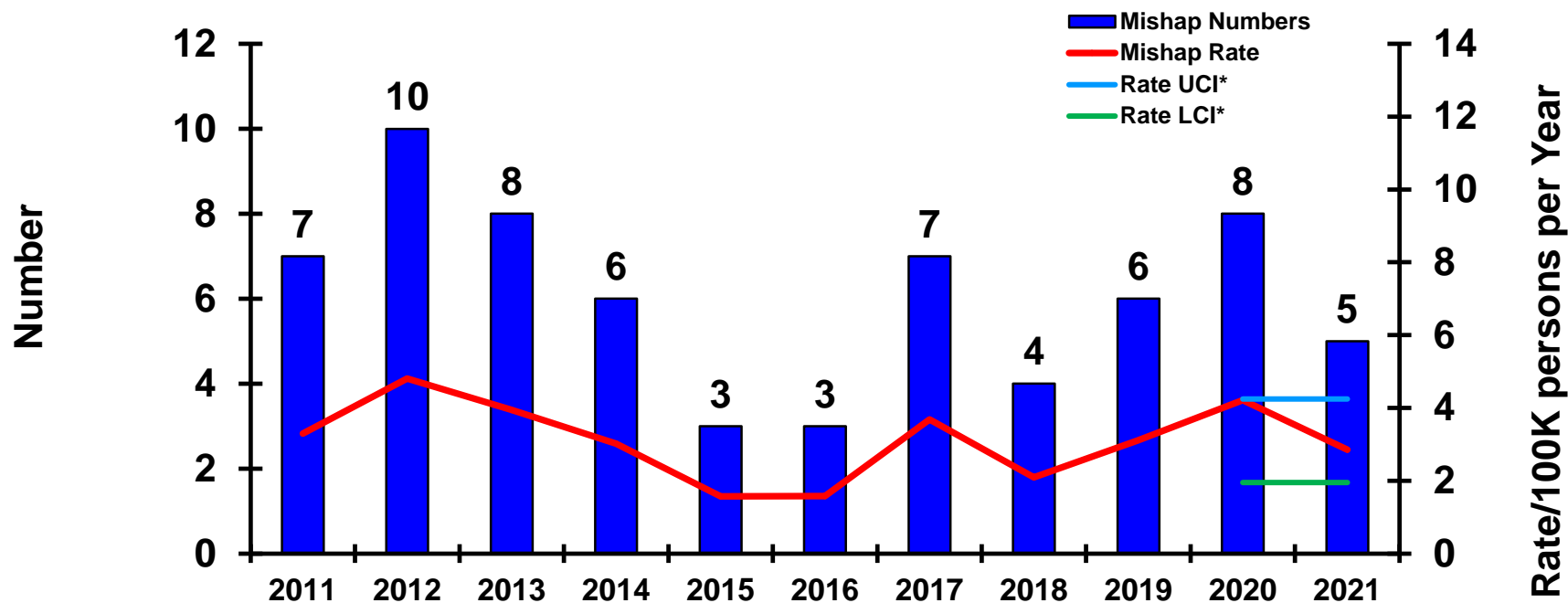

CLASS A GROUND ON-DUTY MISHAPS

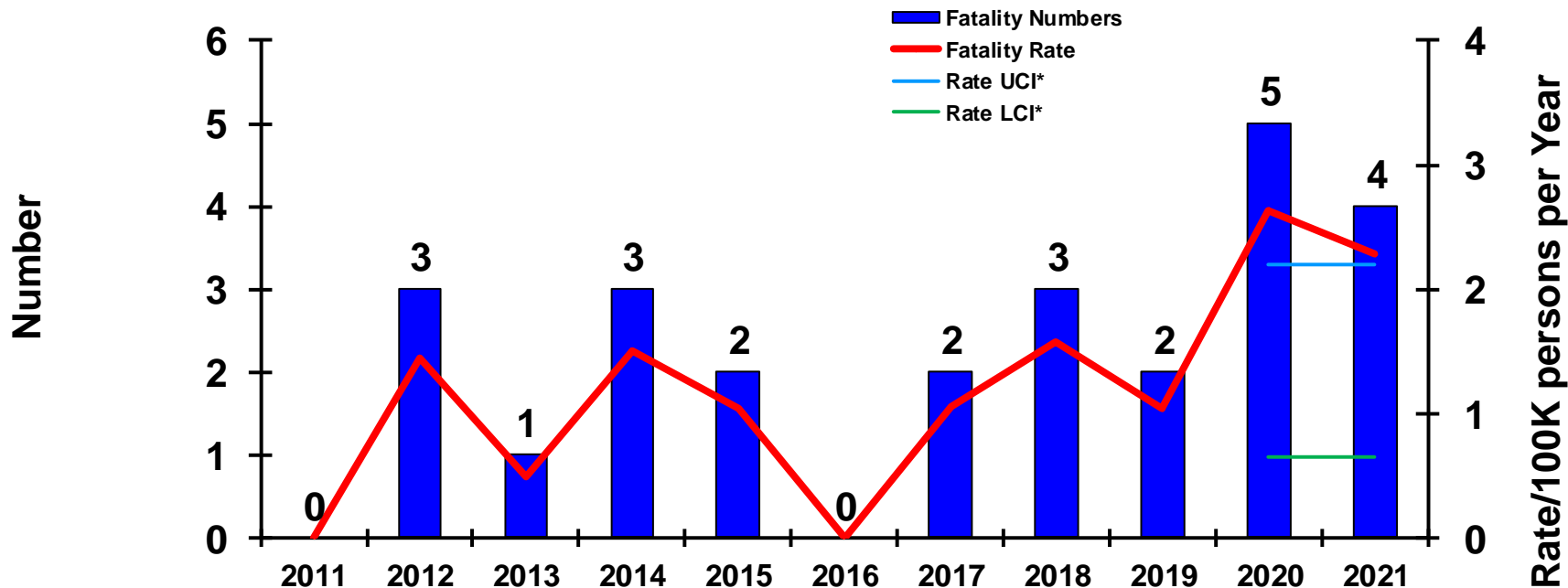

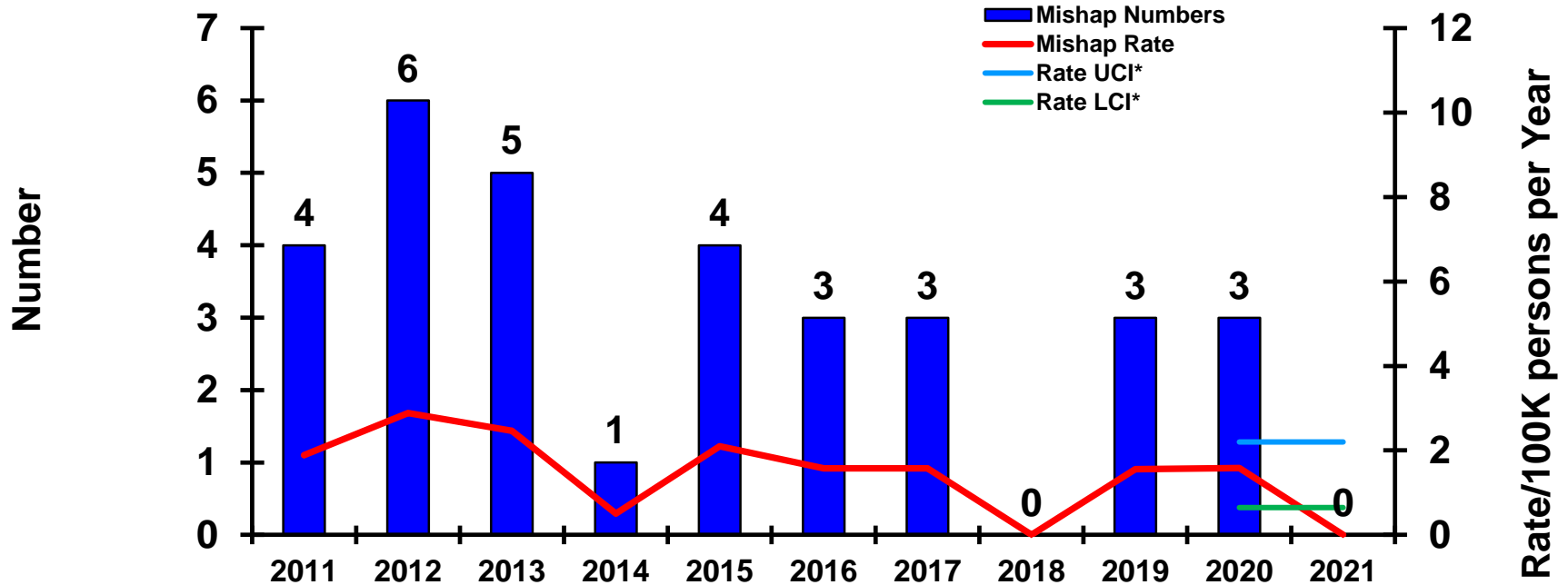

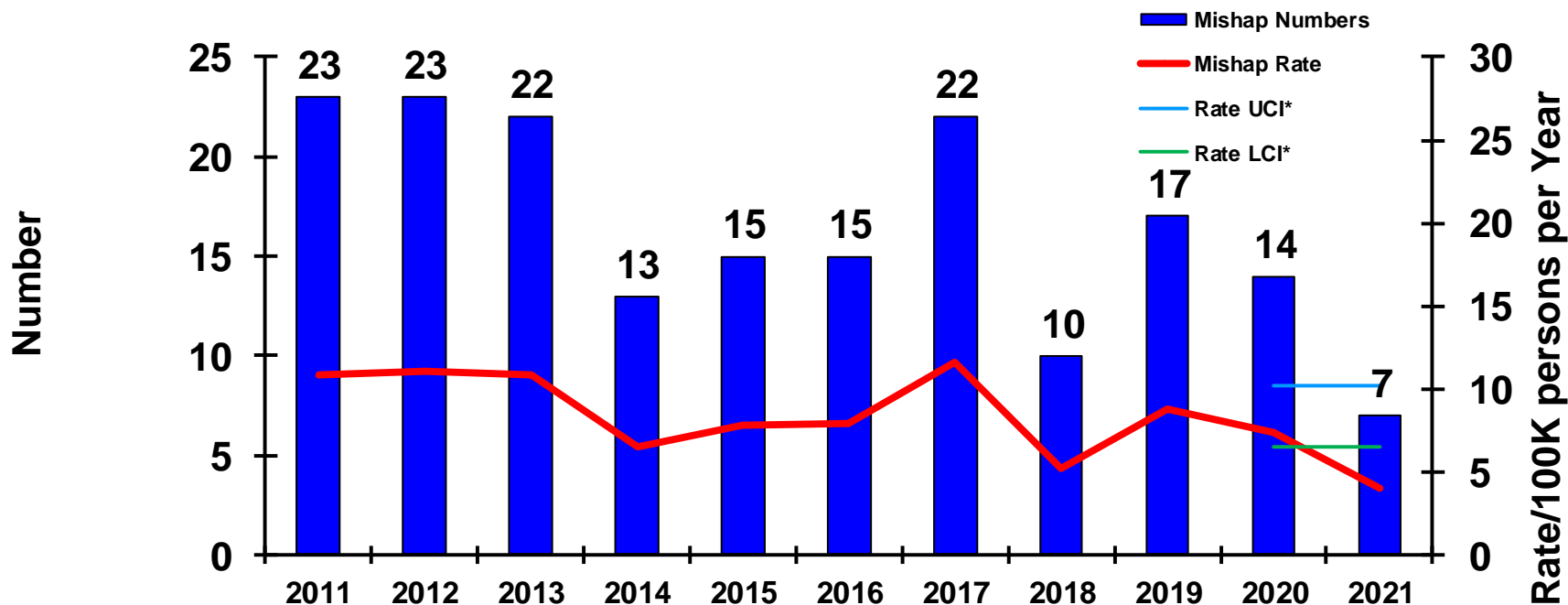

TOTAL CLASS A ON-DUTY MISHAPS

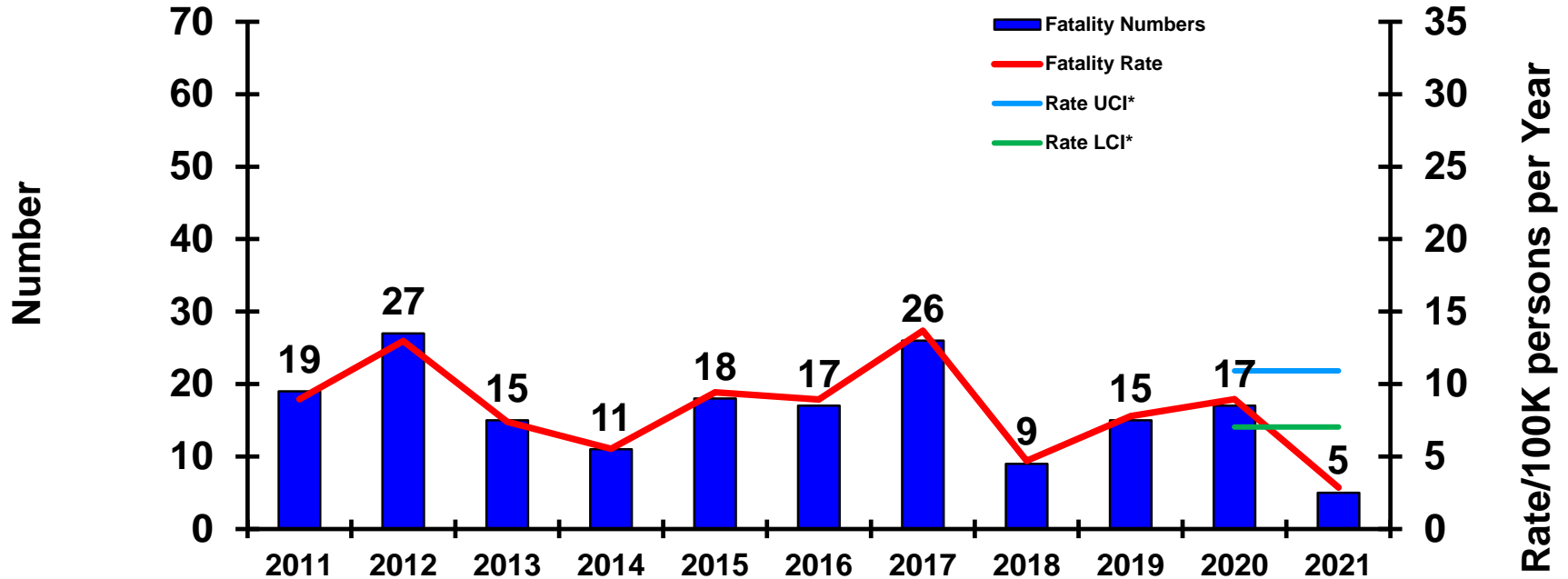

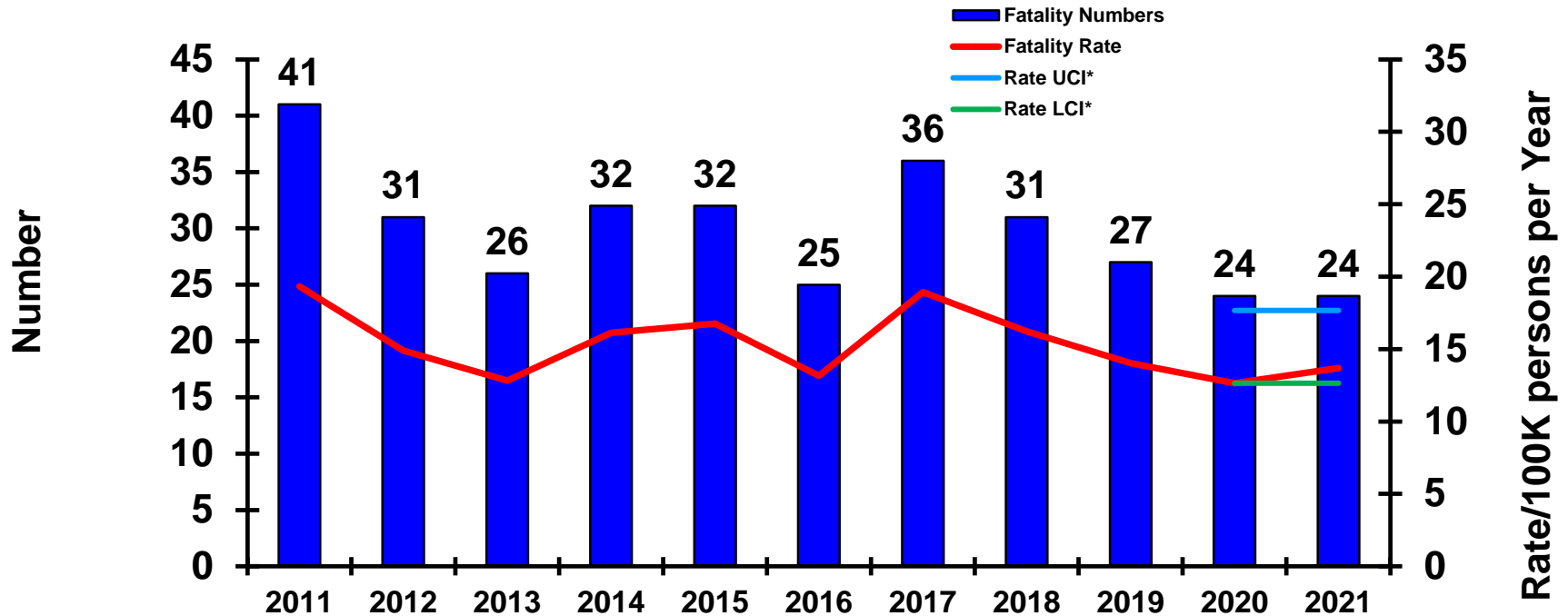

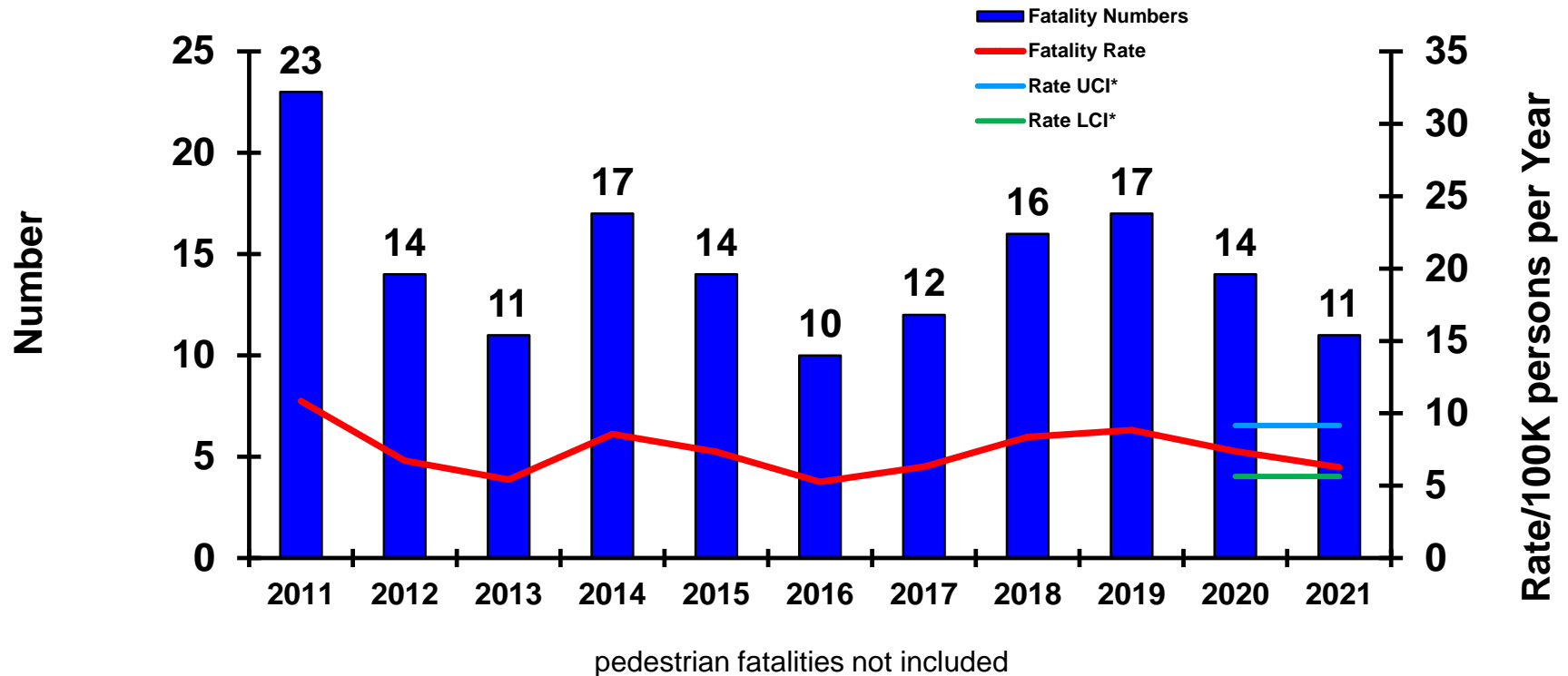

4-WHEEL PMV FATALITIES

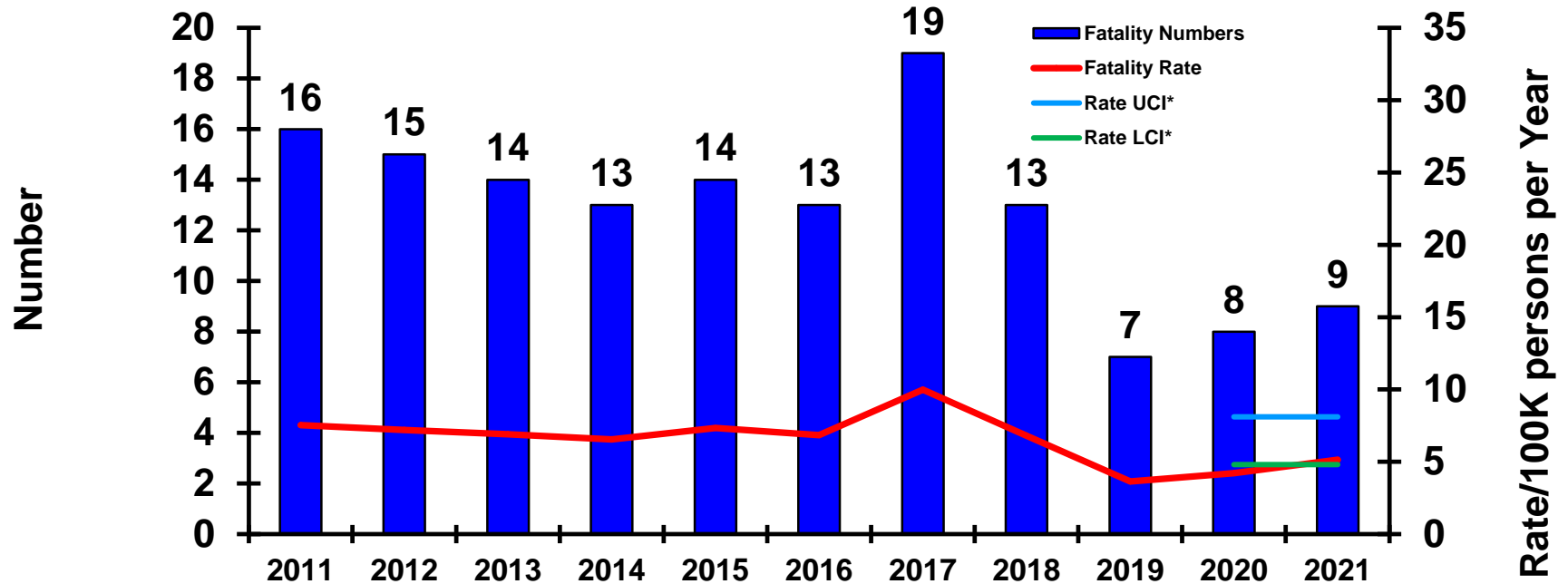

MOTORCYCLE PMV FATALITIES

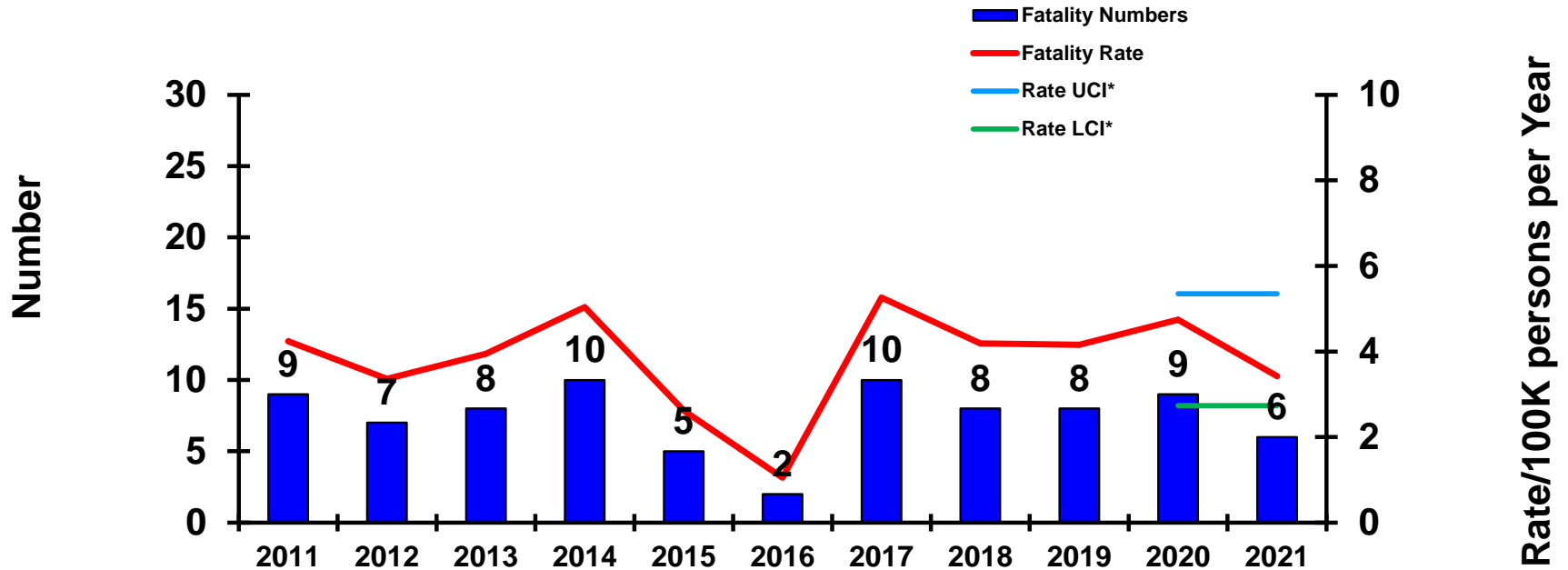

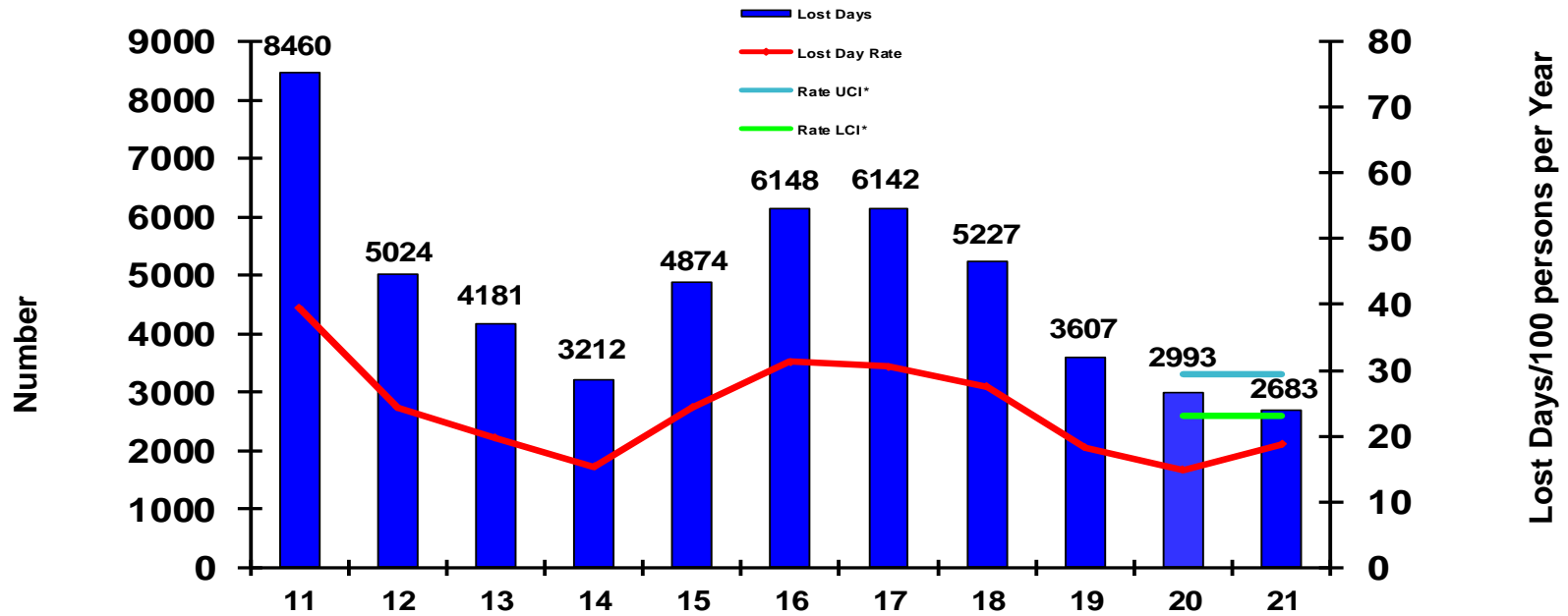

CIVILIAN LOST WORK DAY

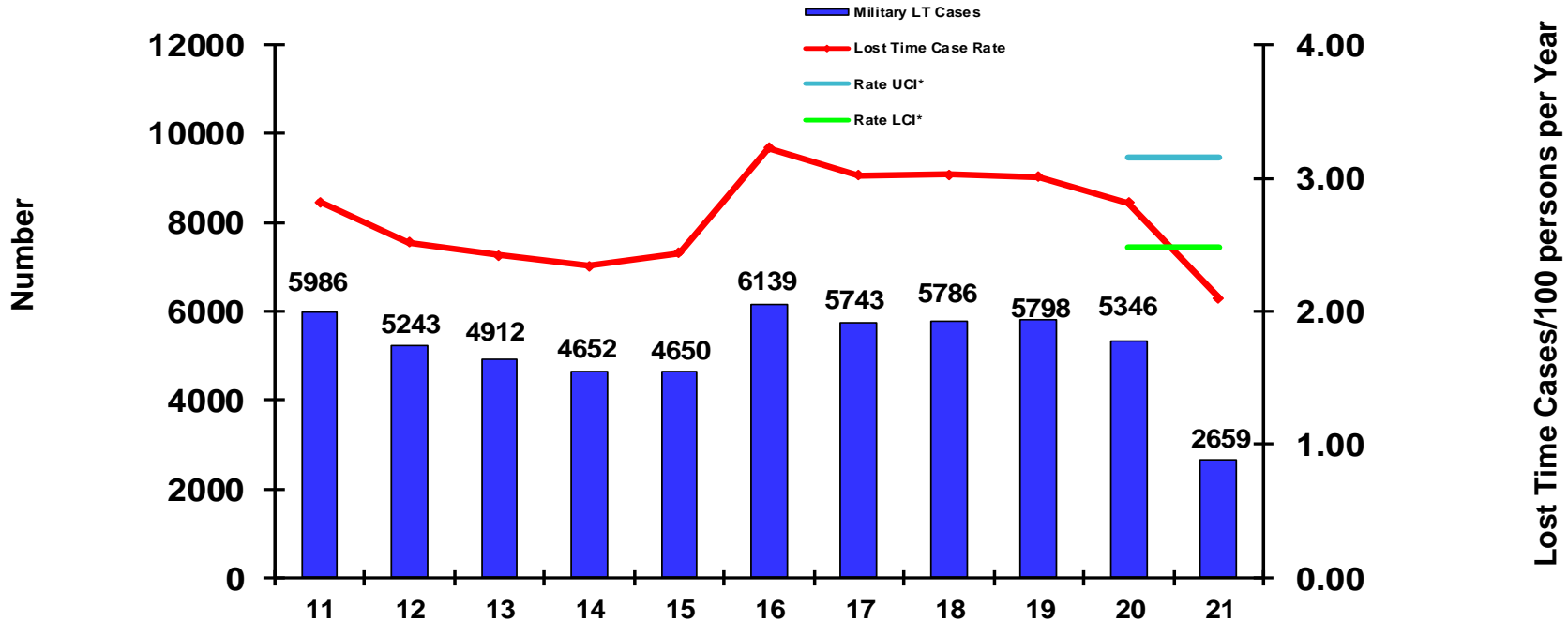

Navy Short Narratives

USN AVIATION CLASS A MISHAPS (includes UAS/UAV, FRMs and AGMs not included in the Flight Slide)

- 31 Aug 2021 (IVO San Diego, CA) After landing on ship, aircraft slid off the deck into the water with six personnel aboard. One crewmember rescued, 5 lost at sea.
- 19 Aug 2021 (NAS Whiting Field, Santa Rosa, FL) TH-57 crashed while conducting instrument training. Significant injuries reported. Both are listed in serious condition.
- 26 Jul 2021 (Lemoore, CA) F/A-18E experienced engine fire during training flight. Recovered without incident. No injury to crew.
- 16 Jul 2021 (IVO Mammoth Lake, CA) MH-60S crashed while conducting mutual aid SAR mission for lost hiker in the Inyo National Forest. No injuries to 4 x aircrewman
- 12 Jul 2021 (IVO Roanoke, VA) F/A-18F sustained FOD damage to starboard intake and starboard engine due to bird strike during low-level. Aircraft recovered safely, no injuries to crew.
- 9 Jul 2021 (Pacific Ocean) Aircraft engine damaged by external FOD during carrier arrestment.
- 17 May 2021 (IVO Kingsville, TX) Two T-45Cs collided during a formation flight. Two successful ejections from one aircraft, the other aircraft safely landed at NAS Kingsville. No injuries reported.
- 26 Apr 2021 (Eastern Pacific Ocean) MQ-8B crashed after departing the perch underway. No fatalities or injuries. (UAV-Flight)
- 24 Mar 2021 (NALF Orange Grove, TX) T-45C crashed after departing the landing pattern. Both crewmembers ejected safely. Aircraft destroyed.
- 22 Mar 2021 (IVO El Centro, CA) : A F/A-18F struck a bird while conducting a low level flight. The aircraft safely returned to base, but the starboard intake and engine were damaged by FOD. No injuries or fatalities reported..
- 16 Nov 2020 (IVO St. Inigoes, MD) At OLF Webster Field, MQ-8C became unresponsive while chocked and chained during a high power maintenance ground turn to test a new battery. Rotor blades ultimately came in contact with the ground causing blade separation and aircraft damage. (UAV AGM)
- 10 Nov 2020 (NAS Point Mugu, CA) MQ-8C crashed on final approach to designated Touchdown Point during Functional Check-Flight. No personnel injured. (UAV)
- 23 Oct 2020 (IVO Foley, AL) T-6B on training mission crashed. Both aircrew deceased.
- 20 Oct 2020 (IVO China Lake, CA) While attempting to return to airport with an in-flight emergency, F/A-18E crashed; pilot safely ejected.

USN SHORE CLASS A MISHAPS

- 17 July 2021 (Undisclosed 6th Fleet) SVM died when shelter roof and chimney collapsed during heavy weather.
- 27 April 2021 (NSA Crane, Indiana) Forklift struck a crate damaging high-valued electronic warfare equipment.
- 15 Mar 2021 (NS Norfolk, VA) Shipyard worker found lodged and unresponsive in the NR2 generator blow-in door. Worker freed, CPR commenced, died at hospital.
- 14 Dec 2020 (Indian Head, MD) Civilian Firefighter/EMT contracted COVID-19 while on duty. FF/EMT passed away on 1 Jan 2021
- 1 Dec 2020 (Patuxent River, MD) CIV U/W ISO USV test. Crew of 16 beginning experiencing COVID-19 systems on 1 Dec. U/W vessel returns to port 10 Dec. Individual reported to hospital, put on ventilator on 13 Dec, removed on 16 Dec, remained hospitalized, succumbed to disease on 4 Jan 2021.
- 16 Oct 2020 (Norfolk NS, Norfolk, VA) SVM hit by forklift at Pier 14, pronounced deceased at hospital.

USN PHYSICAL TRAINING CLASS A MISHAPS

- 5 Apr 2021 (Pensacola, FL) SVM participating in high-risk training pool evolution at Aviation Rescue Swimmer School. SVM found unresponsive in pool, CPR performed, revived. SVM placed in intensive care at hospital. SVM taken off life-support on 13 Apr.

USN ON-DUTY MOTOR VEHICLE CLASS A MISHAPS

- 27 Mar 2021 (Fayetteville, NC) SVM (SELRES-On Duty) SVM as part of Honors Detail was travelling to funeral and was involved in a car accident. Succumbed to injuries on 30 Mar.
- 21 Mar 2021 (Winslow, AZ) SVM, while on PCS orders, involved in multi-vehicle car accident on I-40W. Deceased at scene.
- 2 Mar 2021 (IVO Camp Pendleton, CA) Military convoy of seven vehicles involved in an accident on I-5. 1 x SVM fatality, 1 x serious injury and 4 x minor injuries.

USN PRIVATE MOTOR VEHICLE FATALITIES

- 20 Aug 2021 (Poway, CA) 2 x SVM involved in a fatal car accident. Initial reports indicate that the vehicle was travelling excessively fast, lost control, and impacted a tree. Both SVM pronounced deceased at scene.
- 7 Aug 2021 (San Diego, CA) SVM involved in multi-car/motorcycle accident. Deceased at scene.
- 31 Jul 2021 (Portsmouth, VA) SVM involved in single high-speed motorcycle accident. Deceased at scene of accident.
- 28 Jul 2021 (Norfolk, VA) SVM involved in a motorcycle accident. Succumbed to injuries.

USN PRIVATE MOTOR VEHICLE FATALITIES (continued)

- 24 Jul 2021 (Hampton, VA) SVM riding a motorcycle hit a curb, was ejected and hit a parked vehicle. CPR performed on scene, unable to resuscitate. SVM deceased at scene.
- 24 Jul 2021 (Portsmouth, VA) SVM was passenger in an automobile, crashed into a shipping container. Deceased on scene.
- 23 Jul 2021 (Yamanashi Prefecture, Japan) SVM on leave, involved in a motorcycle accident. Deceased.
- 7 Jul 2021 (Jacksonville, FL) SVM driving in automobile, fatally struck by a tree.
- 3 Jul 2021 (Menifee, CA) SVM struck by motor vehicle in street, CPR performed by EMS, deceased at scene.
- 26 Jun 2021 (San Diego, CA) SVM involved in a fatal motorcycle accident.
- 17 Jun 2021 (Jacksonville, FL) SVM involved in head-on-collision in motor vehicle. SVM was not wearing seat belt at time of accident. Deceased on scene.
- 23 May 2021 (San Diego, CA) SVM fatality due to POV motor vehicle accident while off-duty fatality
- 17 May 2021 (Levittown, PA) SVM lost control of his motorcycle and impacted ground. Deceased on scene.
- 8 May 2021 (Virginia Beach, VA) SVM was passenger in a single-vehicle motor vehicle accident. Pinned in vehicle when caught fire. Deceased on scene.
- 30 Apr 2021 (Berlin, MD) SVM involved in a 2-vehicle PMV accident, died at scene.
- 22 Apr 2021 (Hampton, VA) SVM involved in a motorcycle accident with another vehicle, airlifted to hospital. Succumbed to injuries at hospital.
- 17 Apr 2021 (Warwick Township, PA) SVM, on leave, involved in a single car accident, deceased at the scene.
- 11 Apr 2021 (San Diego, CA) SVM involved in single vehicle motorcycle fatal accident.
- 10 Apr 2021 (Pauma Valley, CA) SVM on motorcycle collided head-on with auto in his lane. Died in hospital.
- 3 Apr 2021 (Perris, CA) SVM involved in single vehicle motorcycle accident. Deceased at scene.
- 28 Mar 2021 (Turlock, CA) SVM involved in motor vehicle accident. Deceased at scene. .
- 15 Mar 2021 (Virginia Beach, VA) SVM involved in a single vehicle accident. SVM not wearing seat belt, deceased at scene.
- 12 Mar 2021 (Chula Vista, CA) SVM involved in motorcycle accident. Deceased.

USN PRIVATE MOTOR VEHICLE FATALITIES (continued)

- 22 Jan 2021 (Waiialua, HI) SVM was riding a motorcycle on Schofield Barracks, lost control. Transported to hospital, succumbed to injuries at hospital.
- 10 Jan 2021 (Norfolk, VA) SVM was riding a motorcycle on I-64W and struck the back of a passenger vehicle when that vehicle changed lanes. SVM deceased.
- 14 Dec 2020 (Misterbianco, Sicily) SVM involved in single-vehicle accident. Deceased at scene.
- 11 Dec 2020 (Jacksonville, FL) SVM was rear-ended and side-swiped while stopped for traffic. SVM taken to hospital with life-threatening injuries, succumbed to injuries on 13 Dec 20.
- 5 Dec 2020 (Center Point, AL) Enlisted USNR on drill weekend involved in a single-vehicle car accident. Vehicle left roadway, hit culvert. SVM was passenger, suffered major blunt injuries and died at scene. Seatbelts were not in use.
- 18 Nov 2020 (Union County, FL). SVM involved in head-on motor vehicle collision. Deceased at scene.
- 2 Nov 2020 (Bakersfield, CA) SVM involved in a head-on auto collision. Pronounced deceased at scene of accident.
- 1 Nov 2020 (Marianna, FL) SVM involved in a single-vehicle accident. Pronounced deceased at scene of accident.
- 30 Oct 2020 (Charleston, SC) SVM died in hospital on 5 Nov after motorcycle was involved in a multi-vehicle head-on collision which also killed spouse.
- 3 Oct 2020 (San Diego, CA) SVM involved in motorcycle accident. Deceased at scene
- 3 Oct 2020 (Virginia Beach, VA) SVM struck by vehicle while riding motorcycle. Deceased at scene.

USN OFF-DUTY/RECREATIONAL FATALITIES

- 29 May 2021 (San Diego, CA) SVM found unresponsive in hallway of Unaccompanied Housing facility.
- 7 May 2021 (Jacksonville, FL) SVM received fatal gunshot wound to head due to accidental discharge of firearm in residence.
- 18 Apr 2021 (North Marianas Island, Tinian) SVM died of apparent accidental drowning while snorkeling in Tinian
- 18 Mar 2021 (Glenville, NY) SVM electrocuted in home, taken to hospital. Succumbed due to injuries on 27 Mar.
- 16 Feb 2021 (Norfolk, VA) Personal firearm belonging to another individual was negligently discharged by SVM causing fatal injury to self.

- 15 Nov 2020 (IVO Pensacola, FL) SVM drowned after disembarking kayak off White Island.

USMC AVIATION CLASS A MISHAPS (includes UAS/UAV, FRMs and AGMs not included in the Flight Slide)

- 13 Jul 2021 (IVO Makurazaki, Japan) 2 x F-35Bs were simultaneously struck by lightning in flight. Both aircraft recovered, no injuries.
- 24 Mar 2021 (NAS Fallon, NV) During start up, an F-35C received foreign object damage to the engine. (AGM)

USMC GROUND CLASS A MISHAPS

- 28 Jul 2021 (Camp Lejeune, NC) SVM was conducting tree felling operations at Paradise Point Golf Course. Struck by falling tree, pronounced deceased at scene.

USMC PHYSICAL TRAINING CLASS A MISHAPS

- 16 Jul 2021 (Greenville, NC) SVM had heat-related incident during command PT. SVM declared brain dead on 1 Aug.
- 10 Jul 2021 (Capital City, MI) During Delayed Entry Program, SNP (POOLEE) participated in organized PT, collapsed during 400m run, CPR administered on scene, died at hospital.
- 4 Jun 2021 (MCRD Parris Island, SC) SVM was found unresponsive during recruit field exercise known as “The Crucible.” Pronounced deceased at scene.
- 22 Apr 2021 (Erbil, Iraq) During morning PT, SVM experienced shortness of breath. During transport to hospital, went into cardiac arrest and efforts to revive unsuccessful. Pronounced deceased.

USMC PRIVATE MOTOR VEHICLE FATALITIES

- **5 Sep 2021 (Ventura, CA) SVM involved in a motorcycle accident. Transported to hospital, died at hospital.**
- 12 Jul 2021 (Jacksonville, NC) SVM was the passenger in a vehicle that slid off the road and collided with a tree on the passenger side of the vehicle. SVM sustained fatal injuries and was pronounced deceased on scene.
- 27 Jun 2021 (Surf City, NC) SVM struck by drunk driver while running on HWY 50. Deceased at scene of accident.
- 26 Jun 2021 (MCAS Yuma, AZ) SVM was involved in a single motorcycle accident aboard MCAS Yuma, AZ, and was pronounced deceased on scene.
- 5 Jun 2021 (Severna Park, MD) SVM was passenger in a fatal single vehicle accident. Pronounced deceased at the scene.
- 2 Jun 2021 (Okinawa, Japan) SVM on motorcycle collided with another vehicle. Pronounced dead at the hospital.
